

Pet Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement

This document may be executed in multiple counterparts, each of which shall be deemed an original but all of which shall constitute one and the same agreement. The exchange of copies of this document and of signature pages by facsimile transmission and/or by electronic mail in Portable Document Format ("PDF") shall constitute effective execution and delivery of this document and may be used in lieu of the original Agreement for all purposes. Signatures of the parties transmitted by facsimile and/or by electronic mail in PDF shall be deemed to be their original signatures for all purposes.

This document contains the entire understanding among the parties and supersedes any prior understanding and agreements between them respecting the subject matter hereof. There are no representations, agreements, arrangements or understandings, oral or written, between or among the parties hereto relating to the subject matter of this document which are not fully expressed herein.

This Agreement includes a release of liability and waiver of legal rights and deprives you the right to sue the owners of Play All Day Doggie Daycare and Boarding LLC and any related parties. Do not sign this agreement unless you have read and understand it in its entirety, seek the advice of legal counsel if you are unsure of its effects.

1. All dogs participating in boarding and or daycare must:
  - Be current on Rabies, Distemper, and Parvo Vaccination
  - Be current on Bordetella vaccination
  - Be in apparent good health and free from fleas and ticks
  - Be spayed and neutered by 7 months of age
  - Be at least 16 weeks of age
  - Be non-aggressive toward other dogs and people (daycare requirement)
  - Not be protective of toys (daycare requirement)
  - Be current on Feline Vaccinations (cat boarding requirement)
2. Your pet will be fed per your instructions provided above, if at anytime during your pets stay the food supplied by you is not sufficient, Play All Day will attempt to contact you to provide more food. If Play All Day is not successful in reaching you, Play All Day will provide the house brand food at \$3-\$5 per meal additional charge, varies by portion size.
3. Play All Day Doggie Daycare and Boarding LLC will not be liable for any lost or damaged property belonging to you or your pet.
4. Prior to being eligible for doggy daycare, your pet must pass a socialization test provided free of charge by Play All Day. If your pet exhibits aggressive or unruly behavior, your pet may be separated from other dogs, and asked not to return to daycare. These decisions are made at the sole discretion of Play All Day Doggie Daycare and Boarding LLC.
5. No pet may be left at Play All Day's facility after the scheduled pickup time without communication from you. If your pet is left without communication for a period of 5 days past scheduled pickup time, your pet will be deemed abandoned. After being deemed abandoned, Play All Day will become the pet's legal owner and guardian. Play All Day will have full rights to re-home or relinquish your pet to a shelter of its choice. If you abandon your pet at Play All Day Doggie Daycare and Boarding LLC., you will be unable to retrieve possession of your pet, and will have no recourse against Play All Day Doggie Daycare and Boarding LLC.
6. You are responsible to disclose, on a continuing basis any medical concerns or behavioral concerns you may have for your pet after the initial application is submitted.
7. Acceptance and Acknowledgement of Risk. You fully understand that there are inherent risks involved with interactions between humans and dogs, as well as interactions between dogs and dogs. These interactions may result in property damage or bodily injury, including but not limited to permanent disability, sickness or death to human or dog. You fully accept and assume all risks and responsibility for all risks, including without limitation all losses, costs, and damages incurred as a result of your dog's participation at daycare, including veterinarian expenses incurred on behalf of, or caused by your pet. Sickness includes any illness not limited to Bordetella (Kennel Cough), Bloat, or any form of contagious disease.
8. Play All Day Doggie Daycare and Boarding LLC. Will have the right to obtain medical treatment for your pet at its sole discretion. If it appears that your pet is ill, injured, or exhibits any behavior that would suggest that your pet may need medical treatment, Play All Day will attempt to seek treatment at the listed vet on file or to Animals R Special Veterinarian Hospital of New Albany if Play All Day is unable to reach your listed veterinarian, or provide transportation to the listed veterinarian. If Play All Day deems that your pet is in need of emergency veterinarian care, Play All Day will present your pet at one of the local emergency offices. If your pet passes away while in the care of Play All Day Doggie Daycare and Boarding LLC. It will be transported to the listed veterinarian or to our partner veterinarian's office. You will be fully responsible for all costs related to any medical treatment, including without limitation the cost of any transportation for any such treatment. You must also provide past veterinarian records to Play All Day upon request.
9. Play All Day Doggie Day Care and Boarding LLC. Has the right to all photographs, videotape, and the use of the material in all media and advertising, social media, on their website without prior approval and they own the rights to photos and videos taken.
10. You further agree to all fees set forth by Play All Day Doggie Daycare LLC. And understand you will be charged for no shows. A full refund is given with cancelation of 24 hours or more. You will be charged \$10 per every 15 minutes or part of thereof past the scheduled closing. 30 or more minutes late will be boarded overnight and charged for an additional day of boarding.
11. Waiver, Release, and Indemnification. You hereby agree to expressly and forever generally waive, discharge claims, indemnify, release from liability, save, hold harmless and defend Play All Day Doggie Daycare and Boarding LLC., their invitees, owners, officers, employees, contractors, volunteers, and all others having an interest in Play All Day Doggie Day Care and Boarding LLC. party from and against any and all injury, liability, claims, litigation, actions, suits, costs, losses, damages, attorney fees, expenses or demands of every character whatsoever on account of, arising out of, resulting from or relating in any way to any act or omission of the release. You agree that this release is binding on you and your successor, legal representation, and assigns. You also expressly and forever release Play All Day Doggie Daycare and Boarding LLC from any duty to protect you and your pet from injury of any kind, and agree that any implementation of safety precautions by Play All Day will not waive Play All Day Doggie Daycare and Boarding's right to be indemnified as provider hereunder, and such precautions will not alter this release.
